FINAL TERMS

The Notes will, when and to the extent that the Temporary Global Note (as defined herein) is exchanged for a Permanent Global Note (as defined herein), be consolidated and become fungible and form a single Series with the EUR 500,000,000 0.750 per cent. Notes 2018 due 11 January 2028 issued on 11 January 2018 as Series No. 1314, which Notes formed the subject matter of Final Terms dated 9 January 2018, the EUR 750,000,000 0.750 per cent. Notes 2018 due 11 January 2028, issued by the Issuer on 24 July 2018 as Series No. 1355, which Notes formed the subject matter of Final Terms dated 20 July 2018 and the EUR 25,000,000 0.750 per cent. Notes 2018 due 11 January 2028 issued on 6 June 2019 as Series No. 1415, which Notes formed the subject matter of Final Terms dated 4 June 2019.

The Base Prospectus referred to below (as completed by these Final Terms) has been prepared on the basis that any offer of Notes in any Member State of the European Economic Area which has implemented the Prospectus Directive (each, a "**Relevant Member State**") will be made pursuant to an exemption under the Prospectus Directive, as implemented in that Relevant Member State, from the requirement to publish a prospectus for offers of the Notes. This document constitutes the Final Terms of the Notes described herein for the purposes of Article 5.4 of the Prospectus Directive and must be read in conjunction with the Base Prospectus, save in respect of the 2017 Terms and Conditions incorporated by reference therein. Full information on the Issuer and the Notes described herein is only available on the basis of a combination of these Final Terms and the Base Prospectus.
